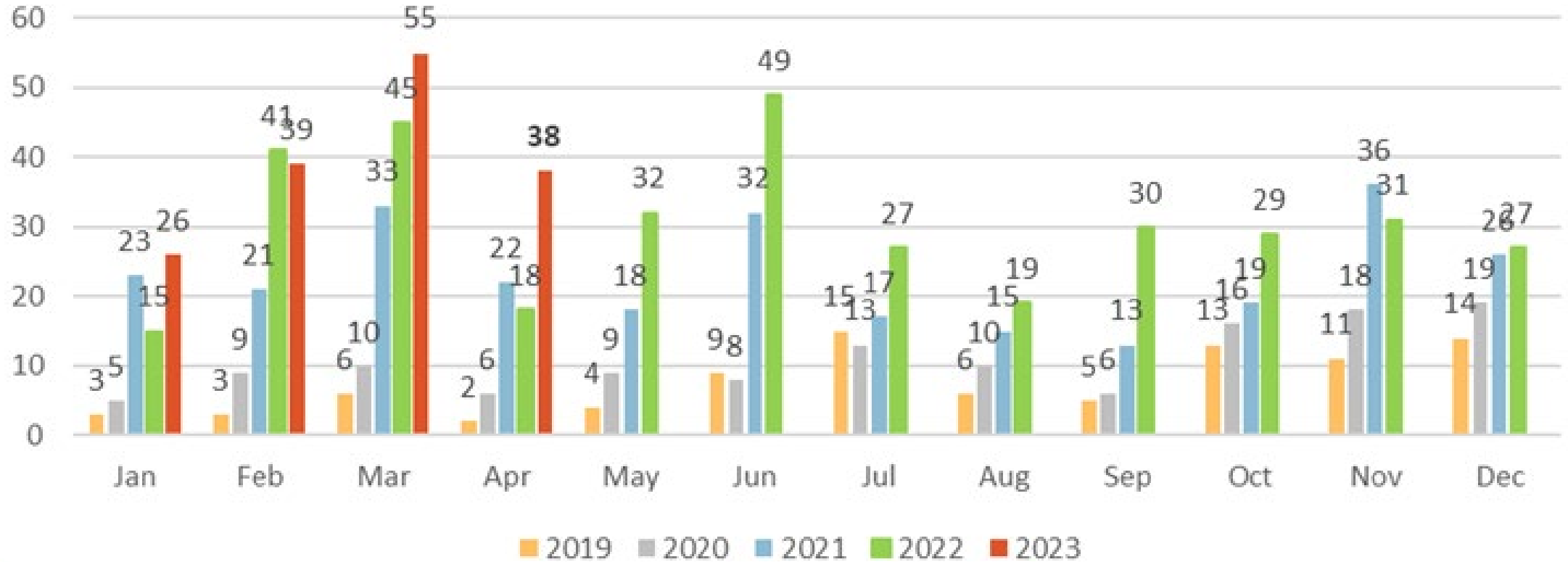

## CII/CPAR

General resources, guides and toolkits about CII/CPAR to help your clinic go-live and maintain CII/CPAR clinic processes.



## Electronic Medical Record

Resources for each conformed EMR vendor on how to use CII/CPAR features such as uploading panels, encounters and consult reports.



## Privacy

Ensure your clinic has a strong privacy and security program with an up-to-date PIA and an endorsement letter for CII/CPAR participation.



## Consults

CII enables your consult reports to be uploaded to Alberta Netcare from your clinic EMR.



## Panels

Panel identification and maintenance processes need to be in place to be identified as the primary care provider in Alberta Netcare and receive eNotifications in your EMR about your patients.



## Encounters

In Alberta Netcare, the Community Encounter Digest is a snapshot of the care a patient has received from all community-based clinics participating in CII/CPAR.

# CII/CPAR Acceleration Grant



## What is the CII/CPAR Acceleration Grant?

Increasing the adoption of CII/CPAR is a primary focus of the Alberta Medical Association and Alberta Health. To support this work, a \$12 million grant was included in the 2022 physician agreement.

The CII/CPAR Acceleration initiative provides compensation to physicians for their time and the administrative requirements to enrol and participate in CII/CPAR.

The grant is entirely funded by Alberta Health. The \$12 million is available on a first-come, first-served basis until the funding limit is reached.

## Who is eligible for the CII/CPAR Acceleration Grant funds?

New and existing physicians who are live on CII/CPAR are eligible for CII/CPAR Acceleration grant funds if they meet all of the following criteria:

1. Family physicians, general practitioners or non-family medicine specialists
2. If they have a practice:
  - In the community with a conformed EMR (including a Primary Care Network clinic) OR

## What is CII/CPAR?

CII/CPAR enables physicians and their teams to share patient information to Alberta Netcare directly from their electronic medical record (EMR).

CII/CPAR enhances communication amongst providers by enabling the sharing of important healthcare information across the province. This two-way connection between clinic EMRs and Alberta Netcare is improving continuity of care between the Patient's Medical Home and Health Neighbourhood.

CII allows providers to send select patient information to Alberta Netcare including consult letters and information about patient visits to contribute to Community Encounter Digests (CEDs).

CPAR identifies relationships between patients and their primary provider and sends eNotifications to providers when their patients are seen in the emergency department, have a hospital admission or day surgery.

## What are the benefits of CII/CPAR?

- Improves continuity of care
- Consult reports are available beyond the referring physician
- Other providers can follow the recommended plan of care
- Timely access to important healthcare information
- Providers across the system can see who the primary provider is in Netcare
- Shares healthcare information between a patient's family doctor and other providers they see

## How to participate in CII/CPAR

1. You must be using one of these conformed EMRs in your clinic:

- Accuro
- Ava (once they receive certification in the next few months)
- CHR
- Healthquest
- Med Access
- PS Suite
- Wolf
- Connect Care (only for AHS-operated primary care clinics)

2. Your clinic must be willing to implement or have already implemented Alberta Netcare

3. Your practice needs to have a privacy impact assessment that reflects the current clinic environment.

## What is the CII/CPAR Acceleration Grant?

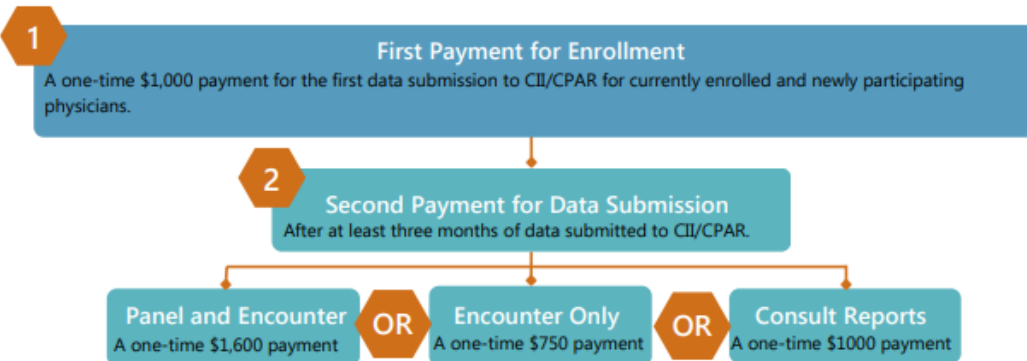

## Who is eligible for the CII/CPAR Acceleration Grant funds?

New and existing physicians who are live on CII/CPAR are eligible if they meet all of the following criteria:

1. Family physicians, general practitioners or non-family medicine specialists.
2. If they have a practice:
  - In the community with a conformed EMR (including a PCN clinic) OR
  - In an AHS-operated primary care clinic (E.g., Family Care Clinics, Family Medicine Clinics)
3. Must be on a fully conformed EMR vendor system: Accuro, Ava, CHR, Healthquest, Med Access, PS Suite, Wolf or Connect Care (AHS-operated primary care clinics).

## Payment Details



- Physicians can only receive a single enrollment and data submission payment. This includes situations where physicians use CII/CPAR at multiple clinics or submit multiple data types.
- To qualify for the panel submission payment, panels must have a panel administrator and a minimum panel size greater than 50 patients for pediatricians and 200 patients for GP/FPs.
- To qualify for the consult report data submission payment, at least 30 consults must be submitted in a three-month period.
