### AMA unveils new land acknowledgement statement

June is National Indigenous History Month in Canada, an annual event that celebrates the rich history and contributions of First Nations, Inuit and Métis peoples. ### Discounts on driver's medical exams

Starting July 1, Alberta seniors will be eligible for a 25% discount on driver's medical examinations. The discount will be provided by Alberta registry offices as a reimbursement.

This means that seniors who took a driver's medical examination from April 1, 2024 to date may be asking for a receipt that includes this information from their practitioner.

To obtain the 25% discount, seniors will be required to present a receipt issued by their practitioner that outlines the following:

- type of service provided
- senior's name
- date of service
- physician's details (e.g., clinic, address, phone number)
- amount paid for the service

costs and create medicolegal liability for practitioners through delayed diagnoses and treatment and missed or misinterpreted result.

### **Section update**

The Section of Generalists in Mental Health Annual General Meeting was held on June 6. The position of secretary-treasurer remains open. In addition, two committees were formed – the Education Committee and the Advocacy Committee. The Education Committee has been tasked with organizing a CME event and the Advocacy Committee is recruiting members to raise the profile of Generalists in Mental Health.

Comments from the AMA Transparency Survey and ideas discussed at the AGM are resulting in the formation of a discussion group (password protected on AMA site) for mental health discussion. Please stay tuned for launch dates.

The membership and focus of the section has evolved over the years and there have been discussions with the AMA regarding billing fees and some of the barriers the section faces. These discussions are ongoing and the AMA has agreed to take these concerns to the Section of Family Medicine, as Generalists in Mental Health is part of that economic section. We are seeking possible solutions from

the membership for solving the issue of how to validate who is qualified to bill as a Generalist in Mental Health provider when working outside of AHS facilities, as the executive has heard loud and clear that consult codes should be billable outside of AHS facilities.
